- VII. Applicant understands that all decisions of the HTEAMS grant committee are final, binding, and not subject to further review, appeal or other action.
- VIII. Applicant certifies that he or she has the authority to complete, sign and submit this application on behalf of himself or herself and or entity applying.
- IX. Current HTEAMS directors, board members and officers and such individuals' family members (spouse, parents, children, grandchildren, and other descendants) including business concerns owned or controlled by these members are not eligible to apply for the grant or receive grant benefits.
- X. Applicant may not use the grant funding for any other objective unless written approval by HTEAMS is granted prior to changes.
